Hence, the students are requested to register for the August / September 2022 End Semester Examinations.

This notification is applicable to students coming under Non functioning Study centre also and pay the fess in the given web-portal.


The last date for payment of Examination Fees by the students is 09-01-2023. The Time Table will be published shortly in the website.

Registration:

The students can register for the August / September 2022 examinations by following the procedure given below.

- The Registration commences **03-01-2023 and ends on 09-01-2023.**
- Login to student Login with Register number through the official web-portal of COE <https://coe1.annauniv.edu>
- Open the **Reg_Preview** and download the **Registration Preview Request Form.**
- Verify the subjects printed on the preview form.
- Fees may be paid online through web-portal and after payment an Acknowledgement form will be generated. **(Debit of payment of fees allowed one time only)**
- Print the preview form, the Acknowledgement received for the online payment and retain the same for future references.

- The students who require Change of Exam Centre with valid reasons and proof if any should be sent to the Mail -Id diseduannauniv@gmail.com . If not permitted further request from students not accepted.**

INSTRUCTIONS TO THE CANDIDATES
WHO EXHAUSTED MAXIMUM PERMITTED PERIOD

The Distance Education Examination Application Pre-view form for the **August /September 2022** Examinations. Arrears of (I, II, III, IV, V and VI Semesters) for P.G. can be downloaded from student login in coe1.annauniv.edu for necessary verification as well as the payment of fees for registration.

- Candidates Eligible for this Special Examination (M.B.A. – Set I to XV , M.Sc. – Set I to XIX & M.C.A. – Set I to XI)
- Candidates who have completed Project Viva Voce Examinations and obtained eligible Percentage of Attendance are only permitted to write the August / September 2022 Examinations (This is the Last Chance for the maximum permitted period of Distance Students Degree Programme)
- Candidates must register for all their arrear subjects (if any). Partial registration is not permitted since they are permitted to write and clear the arrear papers.
- Select any one of the Examination Centres of your choice given in the Annexure – I
- Candidates are requested to clearly mention all their arrear subjects only and register carefully. In case of not mentioning their arrear subjects properly it will forfeit their chance of special appearance for August / September 2022 Examinations. Scheduled Examinations to clear the backlog of their arrear subjects.

• **SPECIAL FEES:**

The candidates who exhausted their maximum permitted period (as per their respective Regulations) have to pay a special fee of Rs.5000/- which is a mandatory to register for the special appearance during August / September - 2022 Examinations.

• **EXAMINATION FEES:**

In addition to the special fee the candidates have to pay the regular Examination Fees as given below:

- ♦ For M.B.A., M.C.A., M.Sc., the fees for theory is Rs.450/- & practical is Rs.450/-

- Those candidates who have not paid the certificate fee earlier have to pay a sum of ₹.1000/- towards issue of Consolidated Statement of Marks, Provisional Certificates and Degree Certificate. These Certificates will be issued as and when the candidate qualifies for the Degree.
